

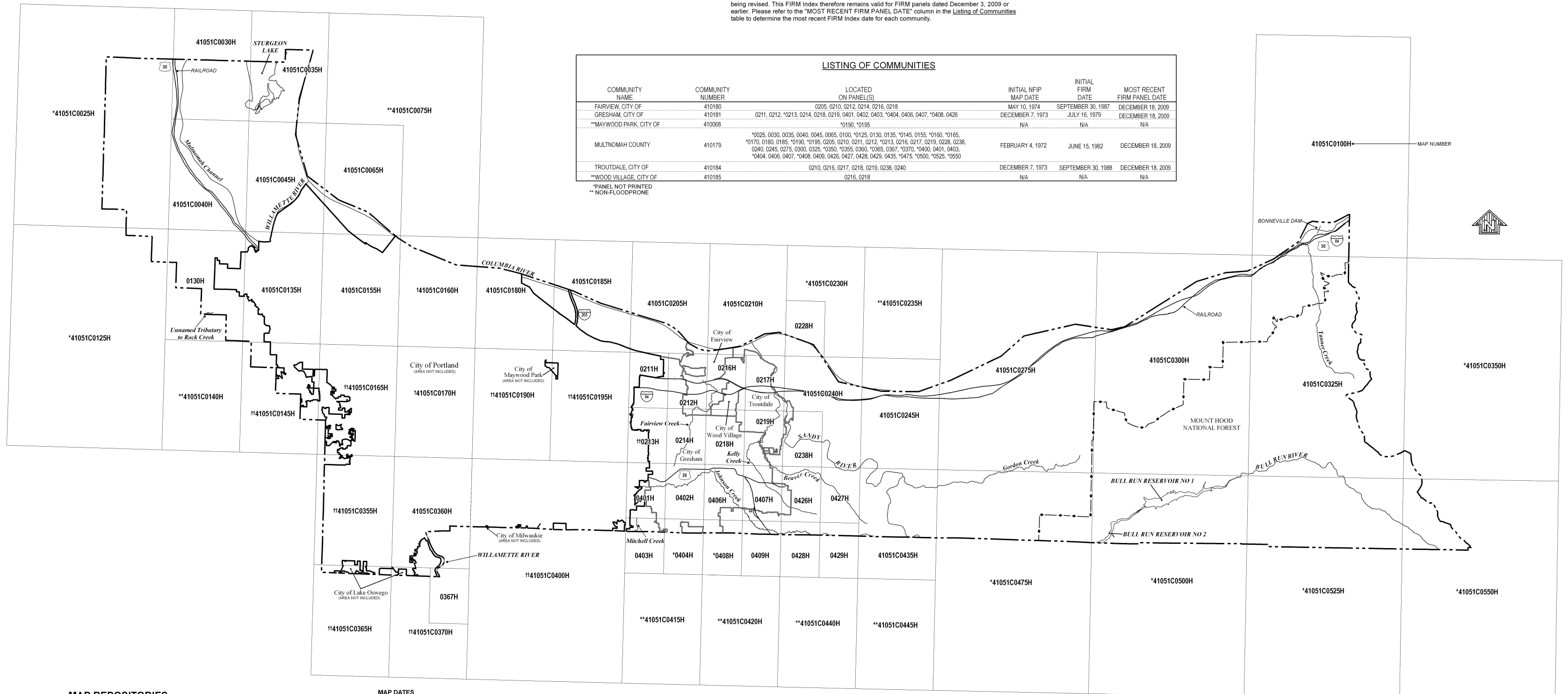
NOTE TO USER
